

5. It is Mandatory for bidders to register under public contracts act no.03 of 1987.

Bids mentioning the name of the Contract on top left-hand corner with separate envelopes shall be delivered in duplicate by registered post or hand to the "**The Chairman, Provincial Procurement Committee (NWP), Road Development Authority, Puttalam Road, Kurunegala**", on or before **14.00** hrs. on **28.05.2024** late bids will be rejected.
