

1. The Chairman, Regional Procurement Committee (Northern Province) on behalf of the Road Development Authority (RDA), invites sealed Bids from eligible and qualified bidders for the project described below.

- 2. The first works consist of rectify and overlay and compact of Dense graded aggregate base and priming. The second works consist of tack coating and asphalt concrete surfacing
- 3. "Bidding will be conducted through the National Competitive Bidding (NCB) since the Estimated Value of work to be performed under this procurement (excluding VAT and other taxes) is below Rs 50 Mn., regional preferences and CIDA grade preference shall apply as stipulated in Public Finance Circular No. 04/2016(iii)".
- 4. To be eligible for the contract award, the successful bidders shall be currently registered with the Construction Industry Development Authority (CIDA) in grade given in the above table in **Highways speciality**.

- 6. The Pre-Bid meeting will be held at 10:00 hrs on 10.06.2024 at the office of the **Provincial Director** (Northern), RDA, Kandy Road, Vavuniya and a site visit will be arranged immediately thereafter if necessary.

A complete set of Bidding Documents in English language shall be purchased by interested bidders on submission of a written application to the Provincial Director (Northern) RDA, Beach Road, Jaffna from 30.05.2024 until 11.06.2024 during 09:00 hrs to 15:00 hrs upon payment of a nonrefundable fee.

Nonrefundable tender fee Rs 5,000.00 (with VAT) for the bidding document can be paid by cash. As per the Public Contract Act No. 3 of 1987, only the Agents and Successful winners of tenders shall be registered in Department of Registrar of Companies.

- 8. Bid shall be accompanied by a Bid- Security for an amount given in the table. Bid Securities shall be valid up to 25.09.2024.
- 9. Bids shall be valid up to 77 Days (28.08.2024).
- 10. Bids shall be delivered in duplicate to the Chairman, Regional Procurement Committee (Northern Province), Road Development Authority, Beach Road, Jaffna on or before 10:00 hrs on 12.06.2024. Late bids will be rejected. Bids will be opened soon after the closing, in the presence of the bidder's representatives who choose to attend.
