The Chairman, Road Development Authority Procurement Committee, on behalf of the Director General, Road Development Authority now invites sealed bids from eligible and qualified bidders for the Supply of One Number 40kVA Three Phase Generator and One Number 15kVA Single Phase Generator to the Road Development Authority and to be installed at the Premises of Multimodal Transport Terminal Development Project in Kandy.

Bidding will be conducted through National Competitive Bidding (NCB)

Bidder shall be manufacturer in Sri Lanka or accredited local agent to the Manufacturer in abroad having the facilities for maintenance and after sales services in Sri Lanka and having experience in supplying and installation and maintenance of Generators in Sri Lanka. A margin of preference for eligible locally produced goods offered "shall not" be applied. Other details are provided in the Bidding Document.

The bidding document will not be mailed.

A pre-bid meeting will be held on 01/08/2024 at 2.00PM (Sri Lanka Standard Time) at the Office of Deputy Director General (Procurement Management)-Road Development Authority, located at 4th Floor, "Maganeguma Mahamedura", No.216, Denzil Kobbekaduwa Mawatha, Koswatta, Battaramulla, Sri Lanka. Maximum of two (02) representatives from each organization will be permitted to attend the pre-bid meeting.

Bids in duplicate must be submitted to the address below on or before 13/08/2024 at 2.00PM (Sri Lanka Standard Time). Late bids will be rejected.

Bids will be opened at the Office of Deputy Director General (Procurement Management)-Road Development Authority, located at 4th Floor, "Maganeguma Mahamedura", No.216, Denzil Kobbekaduwa Mawatha, Koswatta, Battaramulla, Sri Lanka immediately after closing of submission of bids, in the presence of the bidders' representatives who choose to attend in person. All bids must be accompanied by a valid "Bid-Security," for the amount of Sri Lankan Rupees Hundred and Twenty-Five Thousand (Rs. 125,000.00).
