

NOTICE OF AWARD

- 1. The Government of Sri Lanka has applied for a loan (US \$ 60 Mn.) from the Saudi Fund for Development (SFD) towards the cost of the Miscellaneous Foreign Aided Projects (MFAP) and a part of this loan will be utilized for payments under the Contract named above.
